1. INTRODUCTION: Please read these Official Rules (“Rules” or “Official Rules”) of the RSA CONFERENCE 2015 EVALUATE PRESENTATIONS SWEEPSTAKES (“Sweepstakes”). To participate in

the Sweepstakes, you must agree to unconditionally accept and comply with the Rules, and the decisions and interpretations of these Rules by the sponsor and administrator, RSA Security LLC, which is located at 174 Middlesex Turnpike, Bedford, MA 01730 U.S.A. (“RSA” or “Sponsor”). Winning a prize is contingent upon fulfilling all requirements set forth herein. By entering you agree to comply with these Rules. If you do not agree, do not enter or accept a prize. In these Rules, “we” “our” and “us” refer to RSA; “you” and “your” refers to the participants that enter this Sweepstakes.

2. ELIGIBILITY: This Sweepstakes is only open to individuals who can verify to Sponsor’s satisfaction that they: [a] reside in the United States of America or District of Columbia, [b] are of the age of majority in their state of primary residence as of April 20, 2015 (minimum of 21 in Mississippi, 19 or older for residents of Alabama and Nebraska); [c] successfully registered for (“Registration”) and attended RSA Conference 2015 in San Francisco, California between April 20-24, 2015 (“Event”) and received an Event badge (“Badge”); and, [d] complied with these Rules.

3. HOW TO ENTER: To enter, attend, request to have your Badge scanned, complete and submit an evaluation (“Evaluation”) for one or more seminars, tracks sessions and keynotes during the Event (collectively and each individually “Presentation”): **[a]** *Seminars and Keynotes*- full and half-day seminars are offered on 04/20; keynotes are offered 04/21-04/24. **[b]** *Tracks Sessions*- Tracks sessions are offered 04/20-0424.

Your Badge must be scanned at each Presentation you attend to verify your attendance; failure to do so will prevent you from receiving an Evaluation and therefore, from receiving an entry for attending that Presentation. Evaluations must be submitted electronically, either via web browser at <http://rsaconf.quickmobile.mobi/>, or via mobile app (“Mobile App”). Use of Mobile App requires: (i) download and installation on your smart phone or wireless device at <http://www.rsaconference.com/events/us15/downloads-and-media/mobile-app>, and, (ii) set up of user profile including your full name, and business email address. The Mobile App is available in Apple iOS, Android, and HTML versions. Only one user profile per person. At the conclusion of a Presentation, you will also receive an email with information on how to access the Evaluation.

Each Evaluation submitted as described is an “Entry” or “Entries” and eligible individuals who submit an Entry are referred to as a “Participant” or “Entrant” or collectively as “Participants” or “Entrants.” Only one Entry per person per Presentation. Entries are eligible to participate in drawings for the Daily Drawings and Conference Pass Drawing, as described in Chart #1 (individually and collectively, “Entry Period”). Times are measured by the servers associated with the Mobile App or by the digital clock used by Sponsor. Can only win one Daily Drawings prize. Daily Drawings prize winners are permitted to participate in the drawing for the Conference Pass prize. **Odds of winning depend on number of entries received for that drawing.** Not required to answer all questions on the Evaluation to enter. Updates to the agenda will generally be made available during the Event. Agenda is subject to change without notice.

Notwithstanding Chart #1, if for any reason Sponsor is unable to offer Badge scanning at a Presentation, Sponsor may make available a printed Evaluation form. After you request a printed Evaluation form, you must answer the questions on the Evaluation, write in your full name, cell phone number, and email address, and submit the completed Evaluation, as instructed during that Presentation, not later than at that Presentation’s conclusion.

All Entries are subject to the Rules. Entries (including answers to all Evaluations) become the property of Sponsor and their receipt will not be acknowledged or returned. Any attempt by a person to gain more Entries than permitted by the Rules shall result in disqualification at Sponsor's sole discretion. In the event of a dispute concerning who submitted an Entry, the Entry will be declared to have been made by the individual with the name and email address corresponding to the information found on the Entry, but only if that person meets all other eligibility criteria. If any dispute cannot be resolved to Sponsor's satisfaction, the Entry may be deemed ineligible. Entry into the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes during the Event or at any other time.

Entries May Incur Internet Usage Charges. When you submit an Evaluation electronically using your smart phone or wireless device, unless you use the free WiFi provided at the Event, normal Internet access and usage charges imposed by your online service will generally apply, according to the terms and conditions of your service agreement. You understand that by participating in this Sweepstakes by using a smart phone or by providing your mobile phone number as part of an Entry, if you are a potential winner, the Sponsor may contact you via mobile phone, which will be subject to the charges pursuant to your carrier's rate plan.

4. SELECTION OF POTENTIAL WINNERS AND NOTIFICATION: One (1) winner will be randomly selected daily by Prize Vendor to win a "Daily Drawings Prize"; selection will be made each day of the Event within five hours after that day's Cut Off Time. One (1) winner will be randomly selected by Prize Vendor for the "Conference Pass Drawing Prize" on April 24 within five hours after that day's Cut Off Time. The selected Participants will have won a prize subject to fulfillment of all requirements under the Rules. Prize Vendor will contact the potential winner within two business days of being selected by sending an email using the information provided on the Entry. Winners will be asked to provide information such as their full name, address, age, and phone number in order to claim the prize, and to complete, sign and return the Sponsor's Prize Claim Documents defined below to Sponsor within five (5) days of the email notification being sent. **The odds of winning depend on the number of Entries received for that drawing.**

In the event that production, technical, programming or any other reasons cause more than stated number of prizes as set forth herein to be claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

Disqualification. At the sole discretion of the Sponsor, disqualification, and forfeiture may result from any of the following: [1] potential winner's failure to respond to notification of being selected as a winner within five (5) days, or to any other communication sent to the potential/winner within forty-eight (48) hours or such time period provided by Sponsor or Vendor; [2] potential winner's failure to provide satisfactory proof of age, identity, residency or other eligibility as may be requested; [3] potential winner's failure to validly claim any prize; [4] any other non-compliance with Rules; and, [5] if a legal issue presents a significant problem related to awarding a prize to a selected entrant. Winners of the Conference Pass Drawing Prize receive an email with a passcode for complimentary registration to RSA US Conference 2016, and \$500 paid travel expenses toward attendance at the RSA Conference 2016 ("Allowance"), with a combined ARV of \$2,195. Aggregate ARV of all prizes (each a "Prize") is \$4,190. Prizes are subject to "Taxes" below. All travel related and other costs and expenses in excess of the \$500 travel expense allowance associated with attending the RSA US Conference 2016 are to be paid by winner.

The Prize or any alternate prize as described herein represents the complete obligation and entire amount awarded the winner by Sponsor under the Sweepstakes. Prizes are not redeemable for cash and are not transferable. ARV Limitations. The ARV of the Prize is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Sponsor will expend up to a maximum of the ARV of the Prize as stated above for/toward the Prize, but may expend less depending upon the prevailing price, rebates and incentives available at that time. Winner is not entitled to claim any check, cash or other form of payment for the difference in value between the amount paid by Sponsor for/toward the Prize and the Prize's ARV above.

Travel Allowance: The Allowance may not to exceed USD\$500 (“Limit”), and may be expended on or applied toward select categories of travel. Allowance and any Travel are subject to the terms and conditions in this Sweepstakes, and those set forth by the relevant airline carriers, hotels and other relevant providers. All expenses and costs not expressly covered as Travel or in excess of the Limit are the responsibility solely of winner. Travel restrictions, conditions and limitations may apply. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates.

6. GENERAL PRIZE CONDITIONS: Prior to awarding any prize, Sponsor, in its sole discretion, may require Entrants to sign and/or return an affidavit of eligibility, publicity release, any required tax forms, and a liability release benefiting Sponsor (collectively “Prize Claim Documents”) as described herein. Failure to return any of the Prize Claim Documents completed and fully executed within five (5) days of prize

notification and receiving such Prize Claim Documents (or a shorter time if required by exigencies), except where prohibited by applicable law, may cause the prize to be forfeited and potentially awarded to an alternate as solely determined by the Sponsor.

Sponsor shall have no responsibility or obligation to a winner or potential winner who is unable or unavailable to accept or utilize the Prize as described herein.

By accepting the prize, winner also agrees and acknowledges that the randomly awarded prize does not in any way influence any decision in doing business with Sweepstakes Entities, and that the prize was not given in connection with or related to any sale or commercial transaction.
