1. INTRODUCTION: Please read these Official Rules (“Rules” or “Official Rules”) of the RSA CONFERENCE 2016 ASIA PACIFIC & JAPAN SESSION EVALUATION LUCKY DRAW (“Lucky Draw”). To participate in the Lucky Draw, you must agree to unconditionally accept and comply with the

Rules, and the decisions and interpretations of these Rules by RSA, The Security Division of EMC (acting through EMC Information Systems Management Limited (Singapore Branch), which is located at 1 Changi Business Park Central 1, #08-101, ONE@ Changi City, Singapore 486036 (“RSA” or “Sponsor”). Winning the prize is contingent upon fulfilling all requirements set forth herein. By entering you agree to comply with these Rules. If you do not agree, do not enter or accept a prize. In these Rules, “you” and “your” refer to the participants that enter this Lucky Draw.

2. [<https://www.rsaconference.com/events/ap16/downloads-and-media/mobile-app-1>]. Once downloaded, the user must launch the app, click “FIND” and select RSA Conference 2016 – APJ to download the event. Once the event is loaded in the app, each Presentation is listed. Evaluations will be made available within each Presentation within 30 minutes of the session end time. In each Presentation evaluation, your name and email are required in order to enter the Lucky Draw. The Mobile App is available in Apple iOS, Android, and HTML versions. Only one user profile per person.

Each evaluation submitted as described is an “Entry” and eligible individuals who submit an Entry are referred to as a “Participant” or “Entrant” or collectively as “Participants” or “Entrants.” Only one Entry per person per Presentation. Entries are eligible to participate in the drawing for the Prize if submitted before their respective 5:30:00 pm “Cut-Off Time”, as described in Chart #1 below. Times are measured by the servers associated with the Mobile App or by the digital clock used by Sponsor, as applicable. Can only win one Prize. **Odds of winning depend on number of entries received prior to each drawing.** Not required to answer all questions on the evaluation to enter. Prize Daily Drawing: Limitation. Entries submitted before their applicable Cut-Off Time are only eligible to win a Prize on the day the Entry was submitted, i.e., the day the underlying Presentation was held. Entries received after the respective Cut-Off Time are ineligible to win a Prize.

Entry Terms. All Entries are subject to the Rules. All Entries (including answers to all evaluations) become the property of Sponsor and their receipt will not be acknowledged or returned. Sponsor reserves the right in its sole discretion to disqualify any individual who is found in Sponsor's sole judgment to be tampering with the entry process or the operation of the Lucky Draw, the drawing, submission of Entries, Mobile App, or Event website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Lucky Draw, or to annoy, abuse, threaten or

ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE, TAMPER WITH THE ENTRY PROCESS, ONE OR MORE ENTRIES, OR THE SELECTION PROCESS, OR OTHERWISE UNDERMINE THE LEGITIMATE OPERATION OF THE LUCKY DRAW MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO COOPERATE IN THE PROSECUTION OF ANY SUCH INDIVIDUAL(S) AND TO PURSUE ALL REMEDIES TO THE FULLEST EXTENT PERMITTED BY LAW.

Suspension, Modification or Termination. Sponsor reserves the right to modify, extend, suspend, or terminate the Lucky Draw if it determines, in its sole discretion, that the Lucky Draw is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Lucky Draw as contemplated herein. For any such cancellation, termination or suspension, or in the event of any changes made to these Rules, notice thereof will be announced by emailing all Participants having submitted an Entry and/or by posting the information at <https://www.rsaconference.com/events/ap16/about/promotion-rules>. If the Sponsor decides to reconvene the Lucky Draw after a suspension, the determination of the Prize winner will be made from among all eligible, non-suspect Entries received as of the date of the suspension, as Sponsor determines in its sole discretion. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
