This Sweepstakes is open to individuals who: [a] registered for and are attending RSA Conference in San Francisco, California between February 24-27, 2014 (“Event”); [b] are of the age of majority in their state, province or country of primary residence; and, [c] do not reside in an Excluded Territory listed below. • Three ways to enter: [1] Twitter- take a photograph of yourself at the Event, and share it on Twitter with hashtags #SecSelfie #RSAC; OR [2] Vine- create a Vine video of yourself at the Event, upload the video to Vine.co, and tag it with #6Secs #RSAC; OR [3] Write-In- request an entry card during published Event hours from the Event Information Desk or Social Command Center, fill in your name, email address, and “#RSAC”, and return it to the Information Desk or Social Command Center. • Only one entry per person. Pictures and videos must depict only the person submitting the entry. • Up to two chances to win. NO PURCHASE NECESSARY TO ENTER OR WIN. TRADE PROMOTION - NOT OPEN TO THE GENERAL PUBLIC. ODDS OF WINNING DEPEND ON THE NUMBER OF ENTRIES RECEIVED. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. INTRODUCTION: Please read the Official Rules (“Official Rules” or “Rules”) of RSA CONFERENCE TWEET/VINE MARCH 2014 SWEEPSTAKES (the “Sweepstakes”). To participate, you must agree to unconditionally accept and comply with the Rules, and the decisions of, and interpretations of these Rules by, RSA Security LLC, 174 Middlesex Turnpike Bedford, MA 01730. USA (“Sponsor”), which shall be final and binding in all respects. Winning a prize is contingent upon fulfilling all requirements set forth herein. By entering you agree to comply with these Rules. If you do not agree, do not enter the Sweepstakes. In these Rules, “we” “our” “RSA” and “us” refer to the Sponsor; “you” and “your” refers to the individuals that enter the Sweepstakes. All times herein are in Pacific Time.

Sweepstakes Definition. For clarity, a ‘sweepstakes’ as defined in these Rules is the equivalent of a ‘prize draw.’ If applicable within a jurisdiction, references to ‘Sweepstakes’ herein and in connection with this promotion, shall be read as and understood to mean ‘Prize Draw.’

2. ELIGIBILITY: The Sweepstakes is open to individuals who can prove to Sponsor’s satisfaction that they: [1] registered for (“Registration”) and are attending RSA Conference in San Francisco, California between February 24-27,

2014 (“Event”); [2] reached the legal age of majority in their country, province or state of legal residence (in the U.S.A., minimum of 21 in Mississippi, 19 for residents of Alabama and Nebraska) by the date the Event begins; and [3] do not reside in an Excluded Territory (defined below). Employees, staff, independent contractors, agents, officers, directors, members, managers, and other representatives of Sponsor and EMC Corporation (“EMC”), and any of its and their respective parents, subsidiaries, affiliates, sales representatives, advertising-, promotion-, and fulfillment- agencies, legal advisors, and suppliers (including by way example all service providers associated with the Sweepstakes, Sponsor’s website and rewards programs) (collectively and including all the aforementioned entities, the “Sweepstakes Entities”), and the immediate family members (spouses, parents, siblings, children and their spouses and in-laws), and/or those living in the same household of each, are *not* eligible to enter the Sweepstakes or win a Prize defined below.

Void in Excluded Territory. THIS SWEEPSTAKES IS VOID IN PUERTO RICO AND OTHER USA TERRITORIES (OTHER THAN THE DISTRICT OF COLUMBIA), QUEBEC, ARGENTINA, PERU, CHILE, CUBA, SYRIA, IRAN, SUDAN, NORTH KOREA, AND IN ALL JURISDICTIONS WHERE PROHIBITED BY LAW OR REGULATION (INCLUDING BUT NOT LIMITED TO JURISDICTIONS WITH LAWS THAT WOULD REQUIRE REGISTRATION AND/OR TRUST ACCOUNT OR POSTING OF A BOND, OR ANY OTHER REQUIREMENTS THAT HAVE NOT BEEN SATISFIED), OR RESTRICTED OR TAXED BY LAW, AND VOID WHERE RESTRICTED BY INTERNAL BUSINESS OR COMPANY POLICY (COLLECTIVELY, “EXCLUDED TERRITORY”). Residents of an Excluded Territory are prohibited from entering or winning a prize.

3. HOW TO ENTER: There are three ways to enter the Sweepstakes (each an “Entry” or collectively, “Entries”):

[1] Twitter - [a] take a photograph of yourself ONLY at the Event; and [b] share it on Twitter with hashtags #SecSelfie #RSAC. No matter how many times you post a photo, you will only receive one Entry. No group shots are permitted. You must have a personal account with Twitter.com (“Twitter”). Pictures are subject to the limitations published by Twitter and the “Content Restrictions” below. In addition to the picture, Entrants may elect to include in their Tweet, descriptions, thoughts, etc. (collectively, “Optional Material”) along with the Entry; these are not required and won’t affect your chances of winning. The entire Tweet must be 140 characters or less. Only submit an Entry from one Twitter account handle.

OR

[2] Vine- [a] create a Vine video of yourself ONLY at the Event; and [b] upload the video to Vine and tag it with #6Secs #RSAC. No group videos permitted. No matter how many times you post a Vine video, you will only receive one Entry. You must have a personal account with Vine.co (“Vine”). Videos are subject to the limitations published by Vine and the “Content Restrictions” below. In addition to the video,

Entrants may elect to include in their Vine Optional Material such as descriptions, thoughts, etc. along with the Entry; these are not required and won't affect your chances of winning. The entire Vine must be 6 seconds or less of video and 140 characters or less of text. Only submit an Entry from one Vine account handle.

OR

[3] Write-In- Request an entry card ("Card") during published Event hours from the Event Information Desk or Social Command Center, fill in your name, email address and "#RSAC", and return it to the Information Desk or Social Command Center.

Individuals that submit an Entry are referred to as an "Entrant" or "Participant." Only one Entry per person regardless of manner of entry. Entries must be received ("Entry Period") no later than 3:00:00 pm on: (i) February 26th to participate in drawings held on February 26th and 27th; and, (ii) February 27th to participate in the drawing held on February 27th. Entry times for Cards are measured by the digital clock used by Sponsor at the Information Desk or Social Command Center, or by applicable servers at Twitter or Vine. Must be present to enter; not required to be present to win. All Entries are subject to these Rules. Entrants are forbidden from sharing the same email address, Card, Vine video, or Twitter photo. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. Any attempt by a person to gain more entries than permitted by Rules as determined in Sponsor's sole discretion shall result in disqualification. Entry into the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes offered during the Event or at any other time.

Any Entry received or any profile associated with a Twitter or Vine Entry without the attendee's required contact information shall be deemed incomplete and therefore ineligible. In the event of a dispute concerning who submitted an Entry, the Entry will be declared to have been made by the registered account holder of the e-mail address associated with the Card, or the Twitter/Vine account for the potentially winning entrant, but only if that person meets all other eligibility criteria. A registered account holder is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. In the event a dispute regarding the identity of the individual who submitted the Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. Sponsor in its sole discretion, may accept mis-typed Twitter or Vine Entries. Sweepstakes Entities shall not be responsible for defective, incorrect or inaccurate Entry whether caused by entrants, or by any of the equipment, printing, or programming associated with or utilized in the Sweepstakes, or by any technical or human error which may occur in the processing of Registration, or Entries in the Sweepstakes. The Sweepstakes Entities assume no responsibility or liability for any error, omission, interruption, deletion, defect, theft or destruction, or unauthorized access to, or alteration of Entries or Registrations.

Content Restrictions. As determined by Sponsor in its sole discretion, pictures and videos must: [a] be sufficiently in focus, [b] clearly depict the Participant at the Event; [c] include at least a head-shot of the Participant that can be used to identify him or her; and, [d] not, along with any Optional Material, be offensive. Any picture or video Entry or portion thereof (including by way of example, Optional Material, or any gesture, content or text displayed on any shirt, hat, other clothing, or that otherwise appears in the picture) that is, in Sponsor's sole discretion, obscene, lewd, defamatory, hateful, discriminatory, violent, contains any third party mention, disparaging to any third party, Sweepstakes Entities or any third party company, or otherwise violates or infringes (or may infringe) any copyright, trademark, logo, or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light) or entity, or is otherwise objectionable, will disqualify that Entry. Entrants may not copy or otherwise plagiarize the Entry from any source.

Optional Material – License to RSA: All entrants submitting Optional Materials as part of the Sweepstakes will be non-exclusively licensing (with the unlimited right to sublicense) to Sponsor the right to use such materials and content, including any images related thereto, for any purpose (including any and all commercial and non-commercial purposes) with the right to modify the materials and make derivative works thereof in any medium throughout the universe, except to the extent prohibited by law. Entrants represent and warrant that the materials submitted will not infringe or violate any right whatsoever, including, without limitation, any personal rights (e.g., defamation, privacy, false light, moral right, etc.)

or any property rights (e.g., copyright, trademark, right to ideas, etc.) of any person or entity and the use thereof will result in no third party liability or obligations.

Opening a Twitter or Vine Account: Creating a Twitter account or Vine account is free. For Twitter, go to <https://twitter.com/signup>; for Vine, visit vine.co and either login with your Twitter account or download the app for your Android, iOS or Windows phone. Note that you must agree to comply with the Twitter Terms of Service and/or Vine Terms of Service, as applicable, in order to create an account. Information you disclose to Twitter and Vine while opening an account is not shared with Sweepstakes Entities. Sweepstakes Entities shall not be liable for any information shared with either Vine or Twitter to open an account.

May Incur Internet Usage / Carrier Charges: If you upload a photo to Twitter or video to Vine (or open an account with them) other than by free Wifi available at the Event, normal Internet access and usage charges imposed by your online service will generally apply, according to the terms and conditions of your service agreement. Use of a wireless mobile device may only be available via participating wireless carriers, and will result in airtime and carrier charges according to the terms and conditions of your service agreement with your wireless carrier. You understand that by providing your cell phone, Twitter account, Vine account, or email as part of an Entry, if you are a potential winner, Sponsor may contact you via these means, which may also result in charges described above.

4. WINNER SELECTION AND NOTIFICATION: Each day of the Event on or about 4:00 pm one potential winner will be randomly chosen from among all Entries received no later than 3:00:00 pm that day. Sponsor will contact the potential winner using the email address, or by sending a private message via Twitter using the social media profile associated with the Entry. Sponsor must receive a reply by email or a direct Tweet from each potential winner within forty-eight (48) hours of the winner notification being sent as measured by Sponsor's email servers or Twitter's servers as applicable, or an alternate winner may be chosen. Potential winners will have won the prize subject to their fulfillment of all requirements under the Rules. Potential winners will be asked to complete, sign and return Sponsor's Prize Claim Documents defined below. Once returned fully executed and verified by Sponsor, Sponsor will declare the entrant to be a winner. **The odds of winning depend on the total number of Entries received prior to 3:00 pm on that day's drawing.**

Disqualification. At the sole discretion of the Sponsor, disqualification, and forfeiture may result from any of the following (collectively "Disqualified") and an alternate winner selected as described herein: [1] potential winner's failure to timely respond to notification of being selected as a winner, or to any other communication sent to the potential/winner, within forty-eight (48) hours or such other time if explicitly provided by Sponsor; [2] potential winner's failure to provide Sponsor with satisfactory proof of age, identity, residency or other eligibility as may be requested; [3] potential winner's failure to validly claim any prize; and [4] any other non-compliance with Rules. In the event the potential winner is Disqualified, Sponsor will make at least two subsequent attempts to award that Prize by selecting alternate, potential winners in accordance with the above procedure, after which the Prize in question may at Sponsor's sole discretion, go un-awarded. Answering Mathematical Skill Question. At Sponsor’s option, Prizes may be made available at the Event or will be mailed within six weeks (6) after Sponsor declares entrant a winner to the home address as provided on the Prize Claim Documents. Unless provided at the Event, Sponsor will generally be responsible for mailing costs of delivering the prize to winner’s USA residence or if none, to other location reasonably acceptable to Sponsor.

The Prize or any alternate prize as described herein represents the complete obligation and entire amount awarded the winner by Sponsor under the Sweepstakes.
